## Program Delivery Priorities

- Consolidate program learnings to support advocacy for IRCF and other RRR communities.
- Connect IRCF orgs to FRRR supports post program, e.g., SRC and NSW Program Manager, communications, granting and capacity building resources.
- Identify pool of subject matter experts to support capacity building support into the future.
- Share IRCF project case studies, stories and tips to enhance learnings and amplify through FRRR and community communications channels.
- Connect IRCF communities through focus groups to embed post program support, e.g., Digital Hub and NFP Hub networking groups
- Support community events that celebrate community efforts and enhance current momentum.
- Advocate for NFP sector and foster partnerships between key stakeholders with a focus on local councils.
- Support development of future IRCF Partnerships.
- Develop generic culmination framework for all communities.
